Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Surveys were administered to parents, teachers, and school staff to get feedback on expanding learning opportunities for all students. Meetings were held with all members of the Ballard Education Association to discuss the plan. The District utilized the district's Local Control Accountability Plan Committee (LCAP Committee) to seek additional input into the development of the Expanded Learning Opportunities Grant Plan. The LCAP Committee is composed of parents, students, certificated and classified personnel, and school administration. Additionally, the plan was presented to the PTA board on May 10, 2024.

Throughout the school year, teachers provide students with individualized attention and expanded learning opportunities. The District was fortunate that we were able to return students to school early in the 2021 school year, during the pandemic so that learning loss from the pandemic was limited. The District's goal was to address any learning loss in a targeted manner with those students who experienced learning loss. The ELO grant funding is structured to support targeted intervention for students needing support. The funds provide for intervention staff who work with students during and outside the school day. The funds are also used to support before and after school learning opportunities for students. All students are invited to attend the after school program at the YMCA. This is a fee-based program, but the ELOP funds pay the fees for unduplicated pupils. The school provides transportation to Santa Ynez Elementary School where the program is housed. The funds also pay the fee for unduplicated students to attend the YMCA during breaks and holidays, including summer break. The funds also support the enrichment opportunities provided before and after school including: drama, Spanish, Glee club, yoga, art and chess.

A description of how students will be identified and the needs of students will be assessed.

The District is utilizing Dynamic Indicators of Basic Early Literacy Skills (Dibels) as well as the STAR Reading and STAR Math assessments to assess student learning and progress. Classroom teachers and intervention personnel will use these assessment results to monitor progress and inform instruction. Additionally, teachers utilize classroom assessments to pinpoint effective Tier II intervention support. Unduplicated pupils are identified directly by the State as "direct certifications".

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

All students participate in the Dibels and STAR Reading and Math assessments. Parents are provided a summary of the results after these assessments are administered. Teachers inform parents of supplemental services of the classroom teacher and/or the intervention teacher/staff will provide to meet the needs of the students. Additional enrichment and/or support opportunities will be shared via email, the school website, and/or hard copies that are sent home. Parents are also notified of before, after school, and intersession learning opportunities for students. Additionally, parents of unduplicated pupils are notified directly with a letter.

A description of the LEA's plan to provide supplemental instruction and support.

- 1) Teachers will assess each student in the class utilizing STAR Reading and Math, Dibels, and classroom formative assessments to determine each child's academic progress and identify any learning needs. The students requiring supplemental services will be supported individually or in small groups by the classroom teacher or intervention staff during and/or outside the school day.
- 2) The District has instructional assistants in K-5 classrooms to assist with intervention, as well as a 60% Intervention Teacher on Assignment to work with students who need more intensive support individually or in small groups during and/or outside the school day.
- 3) Counseling services: individual and small group activities designed to meet student needs and well-being.

The District is coordinating ELO funds with other sources of state and federal funds including ESSER and IPI funds. These funds coordinate with each other to provide broad-based academic and social-emotional support for students.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California Education Code (EC) Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under EC Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (EC Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, EC Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
